



# Napa Valley College Criminal Justice Training Center Presents

## **Regular Basic Course- Class #114**

### **DATES:**

July 10, 2021 through December 11, 2021  
(Mandatory Academy Orientation: Saturday, July 10, 2021 0700- 1600 hours)

### **DAYS AND TIMES:**

Program days are variable. Class will generally meet Monday through Friday, 0700- 1600 hours. There are also several mandated attendance dates on Saturdays and perhaps Sundays. (As needed)

### **DESCRIPTION:**

The Regular Basic Course is an 880-hour basic training program certified by the California Commission on Peace Officer Standards and Training. Students must complete this course to be eligible for hire as a full-time police officer, deputy sheriff, or level 1 reserve officer in California. Students will experience a high discipline, moderate stress environment that emphasizes the development of character, problem solving skills, and officer safety tactics. Students will experience significant instructional hours dedicated to physical skills, officer safety, and survival. Staff balances physical fitness with demanding academic standards designed to prepare students for success in field-training programs. Students learn through a variety of experiences facilitated by subject matter experts. Students must demonstrate a high level of competency in six "Core Dimensions". Students must be computer literate, as they will conduct research, write reports, and access the academy's website for a wide range of resources. We provide an on-site emergency vehicle operations course. Students will use a skid car to experience realistic emergency vehicle operations. Students experience Firearms training in a state-of-the-art indoor firearms training facility that is one of the best in California.

### **ACCREDITATION:**

The Regular Basic Course is a certified curriculum under the auspices of the California Commission on Peace Officer Standards and Training, and the Accrediting Commission for Community and Junior Colleges. Graduates receive 24 college units and a POST Regular Basic Certificate.

### **ENTRANCE REQUIREMENTS:**

Students must obtain a criminal history clearance prior to applying for this class. Students must also complete a physical exam and receive medical clearance prior to the start of class. Students must demonstrate academic readiness. Applicants must be a high school graduate with a GPA of at least 3.0. Applicants must have taken a math class, higher than algebra II and/or 3 years of foreign language study. Alternatively, applicants may be a college graduate with an earned degree, or by pass the P.O.S.T. Entry-Level Peace Officer Reading and Writing exam with a T-Score of at least 40.0 within the last year. A physical agility test is also required.

### **AGENCY SPONSORED STUDENTS:**

Students sponsored by a law enforcement agency are not required to post a deposit and may receive credit toward the cost of Emergency Vehicle Operations training. The Criminal Justice Training Center invoices agencies for course fees. All students wear the academy uniform. Sponsored students may wear their agency's shoulder patches when authorized.

### **COURSE COST:**

\$3,440.00 includes college registration, books, ammunition, flashlight, handcuffs, range supplies, driver training, a cultural immersion field trip, and some uniform items. The Training Center provides students with a utility belt, firearms rental, and safety equipment. **\$424.00 deposit (non-refundable)** is required to hold a seat in the Regular Basic Course. Students may make the deposit via cash, credit card, or cashier's check. Unless students reach a payment agreement with the training center, they must pay all remaining fees by the first day of the course.

Financial Aid and student loans are available through the college by calling (707) 256- 7300. Students are responsible to be in contact with Financial Aid and provide the Training Center with the information needed. The G.I. Bill may support students in this program.

### **PARKING:**

Parking is available on campus and a permit is required. Semester length permits are available on Napa Valley College's website, [www.napavalley.edu](http://www.napavalley.edu).

### **LAPTOP OR TABLET REQUIREMENTS:**

Students' laptops or tablets must have a keyboard and mouse. They must be capable of accessing the academy's Wi-Fi network. They must be capable of sending and receiving email. They must be equipped with Safari or Internet Explorer, Microsoft Word (2008 or later), Adobe PDF Reader, current version of Java and Flash, at least 16 GB of storage. They must be able to maintain 8 hours of battery life or be AC power connectable. It is highly recommended that the screen be at least 13" and have a least 1 USB port, virus protection software, and Microsoft PowerPoint installed. Students will use laptops or tablets for research, report writing, note taking, and accessing the class canvas website.

### **UNIFORMS:**

Students are required to purchase uniforms from **Suisun Uniforms**. The Training Center recommends students purchase at least the following: one long sleeve uniform shirt, one dress tie, one brass tie bar, two short sleeve uniform shirts, two pairs uniform pants, one pair BDU utility pants, one belt with brass buckle and one name tag.

The academy will provide two sets of physical training uniforms, one set of sweats, a jacket, a hat and a backpack (included in the course cost).

### **HOW TO APPLY:**

Students who meet entrance requirements must apply in person. You must have proof of academic readiness (t-score letter or transcripts), proof of physical readiness, original Department of Justice Firearms Clearance letter, deposit and valid California driver's license.
